year appropriation is available until June 30, 5.1 2025, and the second year appropriation is 5.2 available until June 30, 2026. If this 5.3 appropriation exceeds the total amount for 5.4 which all producers are eligible in a fiscal 5.5 year, the balance of the appropriation is 5.6 available for other purposes under this 5.7 paragraph. A grant 5.26 5.27 award must not exceed 65 percent of the cost of the appropriate technology. A grant award 5.28 must not exceed \$200,000 per station. The 5.29 commissioner must cooperate with biofuel 5.30 stakeholders in the implementation of the grant 5.31 program. The commissioner, in cooperation 5.32 with any economic or community development 5.33 financial institution and any other entity with 5.34 which the commissioner contracts, must 5.35 submit a report on the biofuels infrastructure 5.36

financial assistance program by January 15 of 6.1 each year to the chairs and ranking minority 6.2 members of the legislative committees and 6.3 divisions with jurisdiction over agriculture 6.4 policy and finance. The annual report must 6.5 include but not be limited to a summary of the 6.6 following metrics: (i) the number and types 6.7 of projects financed; (ii) the amount of dollars 6.8 leveraged or matched per project; (iii) the 6.9 geographic distribution of financed projects; 6.10 (iv) any market expansion associated with 6.11 upgraded infrastructure; (v) the demographics 6.12 of the areas served; (vi) the costs of the 6.13 program; and (vii) the number of grants to 6.14 minority-owned or female-owned businesses. 6.15 The base under this clause is \$3,000,000 for 6.16 fiscal year 2026 and each year thereafter; 6.17 (4) \$1,250,000 the first year and \$1,250,000 6.18 the second year are for grants to facilitate the 6.19 start-up, modernization, or expansion of meat, 6.20 poultry, egg, and milk processing facilities. A 6.21 grant award under this clause must not exceed 6.22 \$200,000. Any unencumbered balance at the 6.23 end of the second year does not cancel until 6.24 June 30, 2026, and may be used for other 6.25 purposes under this paragraph. The base under 6.26 6.27 this clause is \$250,000 in fiscal year 2026 and each year thereafter; 6.28 6.29 (5) \$1,150,000 the first year and \$1,150,000 the second year are for providing more fruits, 6.30 vegetables, meat, poultry, grain, and dairy for 6.31 children in school and early childhood 6.32 education centers, including, at the 6.33 commissioner's discretion, providing grants 6.34 to reimburse schools and early childhood 6.35

7.26	second year. Any unencumbered balance at
7.27	the end of the second year does not cancel

7.31	(7) \$2,000,000 the first year and \$2,000,000
7.32	the second year are for urban youth
