**RE:** Summary of Senate Finance Committee Actions

Members of the Senate Finance Committee,

This memo provides a high-level summary of the bills that have been passed out of the Finance Committee and the amendments that have been adopted to the supplemental finance bill vehicle (H.F. 2433). This memo covers the period of Monday, April 20, through Wednesday, April 29.

**State Government** (Monday, April 20)

The [A17](#) and [A21](#) amendments to H.F. 2433 (the supplemental budget vehicle) were adopted. H.F. 2433, as amended, was laid over. The [A20](#) and [A21](#) amendments to [S.F. 203](#) (the Housing omnibus bill) were adopted. S.F. 203, as amended, was recommended to pass and sent to General Orders.

**Transportation** (Wednesday, April 22)

[S.F. 3988](#) (the Transportation omnibus bill) was laid over without amendment.

**Environment** (Wednesday, April 22)

The [A34](#) amendment to H.F. 2433 (the supplemental budget vehicle) was adopted. The A34 included an oral amendment to make it a DE amendment. H.F. 2433, as amended, was laid over. The [A27](#) amendment to [S.F. 4365](#) (the Commerce and Consumer Protection omnibus bill) was adopted. S.F. 4365, as amended, was recommended to pass and sent to General Orders.

**Memorial Bills** (Friday, April 24)

The [A7](#) DE amendment to [S.F. 3899](#) (memorial bills) was adopted. S.F.3899, as amended, was recommended to pass and sent to General Orders.

**Higher Education** (Friday, April 24)

The [A13](#) amendment to [S.F. 3943](#) (Higher Education policy omnibus) was adopted. S.F. 3943, as amended, was laid over. **Gun Violence Prevention Bill** (Tuesday, April 28; Wednesday, April 29)

On Tuesday, April 28, the [A19](#) DE amendment to [S.F. 3655](#) (gun violence prevention bill) was adopted. An oral amendment to the A19 was adopted. The oral amendment was on page 5, section 5, subdivision 2, and deleted the last sentence of paragraph (a) and deleted all of paragraph (b). S.F. 3655, as amended, was laid over.

On Wednesday, April 29, the [A7](#) and [A8](#) amendments to [S.F. 4067](#) were adopted. The A7 DE amendment reflected the work of the Committee from Tuesday, April 28. S.F. 4067, as amended, was recommended to pass and sent to General Orders.

**Medicaid Fraud** (Wednesday, April 29)

The [A54](#) amendment was adopted to H.F. 2433 (the supplemental budget vehicle) was adopted. H.F. 2433, as amended, was laid over.
