# Chapter 88 – Miscellaneous capital projects appropriations modifications (HF 3631)

**Article 1** amends earlier appropriations from the general fund enacted or previously amended in capital investment bills.

**Article 2** amends earlier appropriations from the bond proceeds fund enacted in capital investment bills.

**Article 3** amends earlier appropriations from trunk highway bond proceeds enacted in the 2021 and 2023 transportation omnibus bills.

**Article 4** amends the month for the cancellation report.

The amendments in Articles 1, 2, and 3 modify the description of the project or extend the availability of an appropriation.

Nothing in the bill appropriates any additional money.

All articles are effective the day after final enactment.

## **Article 3 – Trunk Highway Bonds**

This article extends the availability of two appropriations from the bond proceeds account of the trunk highway fund, for bond sale expenses, by changing the date that the four-year cancellation period starts to run, based on the date of availability of portions of the appropriations. The 2021 appropriation amended in section 1 has portions available beginning in 2022, 2024, and 2025. The 2023 appropriation amended in section 2 has portions available beginning in 2024, 2025, and 2026. The four-year cancellation period will begin running on the first day of the fiscal year in which the portion of the appropriation is available, instead of from the date of enactment. The appropriations were originally enacted in Transportation omnibus bills.

#### Article 4 – Miscellaneous

**Section 1 [Reports; 16A.642, subd. 1]** changes the due date, from January 1 to February 1, for the annual cancellation report generated by the commissioner of management and budget. The cancellation report lists projects for which bond proceeds were appropriated more than four years earlier that have unspent and unencumbered balances.
